DuTrac Community Credit Union announces its Academic Scholarship Program. This program is available to graduating high school seniors who have been members for at least one year and whose account is in good standing.* The scholarships recognize members of DuTrac who demonstrate scholastic excellence, extracurricular and community involvement, and are interested in advancing their education at an accredited community college, trade school, technical college, or university. Up to seven (\$1000) non-renewable scholarships will be awarded to qualified student(s). Applicants may qualify for only one award.

SAFEGUARD YOUR WEALTH: UNMASKING THE 2024 TAX AND IRS SCHEMES

In the digital age, where technology and communication seamlessly intertwine, scammers have become increasingly sophisticated in their attempts to defraud individuals. One prevalent avenue for exploitation is through tax and IRS scams. As we approach tax season, it's crucial to be vigilant and informed to protect yourself from falling victim to these deceptive practices.

Common Scam Techniques:

- **1. Phone Scams:** Scammers may call unsuspecting individuals, posing as IRS agents, and claim that the person owes back taxes. They use intimidation tactics, such as threats of arrest or legal action, to coerce victims into making immediate payments.
- 2. Phishing Emails: Fraudulent emails claiming to be from the IRS may ask recipients to click on links or download attachments, leading to malicious websites or malware installations. These emails often request information, such as Social Security numbers or bank account details.
- **3. Fake Tax Preparation Services:** Scammers may set up fake tax preparation services, promising high returns or low fees. They use this quise to collect personal information, which can be used for identity theft or other fraudulent activities.
- **4. Identity Theft:** In some cases, scammers use stolen personal information to file fraudulent tax returns, claiming refunds on behalf of unsuspecting victims.

Protecting Yourself from Tax Scams:

- **1. Verify Caller Identity:** The IRS does not initiate contact with taxpayers by phone. If you receive a call claiming to be from the IRS, hang up and verify the legitimacy of the call by contacting the IRS directly using official contact information.
- **2. Be Wary of Emails:** The IRS does not initiate contact with taxpayers via email to request personal or financial information. Avoid clicking on links or downloading attachments from unsolicited emails.
- **3. Use Reputable Tax Professionals:** When seeking assistance with tax preparation, choose licensed and reputable tax professionals or tax preparation services. Research their credentials and reviews before sharing any sensitive information.
- **4. Secure Personal Information:** Safeguard your Social Security number, bank account details, and other sensitive information. Be cautious about sharing such information, especially in response to unsolicited communication.
- **5. Monitor Your Finances:** Regularly review your financial statements and credit reports to detect any unauthorized or suspicious activity. Report any discrepancies to your financial institutions and the IRS promptly.

Stay informed, be skeptical of unsolicited communication, and verify the legitimacy of any requests for personal or financial information.

The following items will be needed for the deposit of your tax refund:


- DuTrac's routing number: 273974549
- The checking or savings account number you would like the refund deposited into. (No subshare accounts.)

If you would like your refund deposited into your DuTrac savings account, please select the savings option on your tax form(s) and provide your membership/account number. (Do not include any dashes. Do not add an additional 0 to your membership number.)

If you would like your refund deposited into your DuTrac checking account, please select the checking option on your tax form(s) and provide your checking account number. This number can be found at the bottom of your check in the center or it can be found through our mobile app. Once you are signed in, click on your checking account to open the history, then click on details. Your checking number is the MICR number. (Please do not include any dashes.)

If you are unsure about your savings or checking account numbers please contact your local DuTrac office at 563-582-1331. This information applies to all automatic deposits or withdrawals from your DuTrac checking or savings account(s).
